The Superintendent reached out to the community in multiple ways to inform them of a public forum to discuss and take input on the formation of the ESSER III Expenditure Plan. The date for the public meeting, October 6th, 2021, was advertised at two regular scheduled SPJUSD Board meetings, posted on our web page and a district-wide all-call was sent out a week prior to the meeting. At this meeting the Superintendent presented a PowerPoint slide show that detailed the purpose of the Elementary and Secondary School Emergency Relief funds under the American Rescue Act. This presentation went into detail about the allowable uses, constraints, timeline and the funding amounts. The district also presented a proposed allocation that fit into these guidelines. There was time provided for questions, suggestions and other comments.

The main input received at this meeting was about extending the year and/or adding additional time for learning loss. This is one of the main reasons the district is focusing funds to Summer school and offering additional tutoring. Each area of our plan is focusing on all students we serve including English Learners, students of color, foster youth, homeless students, students with disabilities and migratory students.

## Introduction

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
