The summit was held in Sacramento on April 11-13. Over 800 people attended with probation, CPS, school psychologists and student services personnel represented.

LAUSD was the largest representation: They have 9000 Foster Youth.

Workshops: Most I attended related to working with local agencies and also advice on completing the LCAP. The most beneficial workshop involved only District Liaisons, where I met my local counterparts. There, I discovered we do not know the funding allocation for 2016-17.

There were some things I think we should implement at the site levels.

- 1. District Liaison meet with foster parents upon enrollment.
- 2. 30 day follow up with the student, principal, district liaison, foster parents and student.
- 3. Social worker should be on emergency contact list.
- 4. Are measurable objectives, specifically for foster youth, in place? (Esp crucial at high school level.)

Challenges districts face include:

- keeping track of the foster youth population
- 2. truancy of foster youth
- 3. preparation for college entrance
- 4. transportation
- 5. lack of engagement (parents/guardians, students)
- 6. meeting their "soft" needs. One current foster youth spoke up and stated that, "Everyone wants to help, but no one wants to listen."
