 - d) Ohana House Update-Although CDE approved providing services through support of the purchase of transitional housing for Sierra County foster youth students to transition from high school to Feather River College, they are now questioning our action. Dr. Grant, Nona Griesert and Hannah Tomatis had a conference call with Tom Herman and Jackie Wong of CDE and answered many questions. They indicated they will do more research.

 Liaison should be meeting with teachers and parents during educational evaluations

 Bring back Rapping Dad or something similar to aid school employees in understanding foster youth and
 their individual and unique situations
