1. Presentation - Nurturing Parenting Program

Presenter: Tammy Muldoon, Executive Director of the High Sierras Family Resource Center We have been doing the Nurturing Parenting program since 1987. It was introduced again to the child abuse prevention community as an evidence based program a few years ago. Two years ago multiple people in Sierra County were trained to do this program, so it is officially two years old for us. Unofficially 32 years.

Have served 145 kids so far—1 out of every 4 kids in Sierra County.

Meeting with families wherever they are at and sitting with them as long as it takes to figure out what they can do to move ahead—get past any issues they are dealing with: poverty, drug abuse, mental health issues, truancy, distrust of authority, etc. We work to address changing peoples' attitudes so they can help their kids better.

Main issue emerging is that parents are not understanding their children's feelings and behaviors. We work to help parents recognize better ways to take care of themselves in order to see and understand how they can better care for their children.
